Definitions	
Affiliates	Companies related by common ownership or control. They can be both financial and non-financial companies. • Western Sun FCU does not have any.
Non-Affiliates	Companies not related by common ownership or control; they can be both financial and non-financial companies. • Western Sun FCU does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products and services to you. • For example, credit card companies and insurance companies.
